- i. RIGHT TO SELL
 - a. The consignor states that they own the merchandise (items) free of any liens and has the full rights to sell or otherwise dispose of them. In accordance with this agreement, the consignor grants the consignee an exclusive right to sell the item(s) on eBay®, the online auction website with the following terms:
- ii. The Consignment Process
 - a. All aspects of the transaction will be conducted under the consignee's eBay ID Globalduk
 - b. Acceptance of any item for consignment will be at E-Seller4U's sole discretion.
 - c. E-Seller4u will start the auction(s) and handle all aspects of the sale including correspondence with bidders, accepting payments, and mailing of the item.
 - d. E-Seller4u will collect payment from the winning bidder (buyer) at the end of the auction and will ship the items in a timely manner, once funds have cleared unless other arrangements have been made.
 - e. Payment will be sent to the consignor on the 15th of each month for auctions that have been paid, shipped, and received without dispute by the 30th of the previous month.
 - f. E-SELLER4U cannot guarantee that the consignor's items will sell.
 - g. E-Seller4u will take all precautions to keep auction lots in their current condition. The consignor will hold E-Seller4u harmless for any damage that happens during the auction process and should maintain any current insurance or warranty papers on the auction lots.
 - h. Items that have not sold must be picked up by the consignor within 30 days of the last listing period. Any items not retrieved will become the property of E-SELLER4U.
- iii. Fee's and Commissions
 - a. All fee's and commissions are per auction lot based on the service level chosen.
 - i. Basic Service
 - 1. No up front fee
 - 2. 99 cent starting price
 - 3. 7 day auction
 - 4. Enough pictures to adequately show the item
 - ii. Premier Service
 - 1. \$9.99 up front fee per auction lot. This fee is non-refundable if the auction lot does not sell. This fee will be credited towards any commission due E-Seller4u if the auction lot does sell.
 - 2. Consignor may set the start price of the auction lot
 - 3. Gallery picture
 - 4. Unlimited pictures
 - 5. Consignor may set a buy-it-now price (optional)
 - 6. 10 day auction (optional)
 - 7. Title of auction will be bold to help it stand out more
 - b. E-Seller4u commission on the final sale price of each auction lot (item)
 - i. 34% commission on the first \$200
 - ii. 29% commission on \$201 - \$500 in sales
 - iii. 24% commission on \$501 on up in sales

iv. Penalties

- a. The consignor agrees not to bid on auctions that E-Seller4u has listed for them on eBay, this is known as shill bidding. A \$75 penalty fee (per offense) and the possibility of not being able to use the services of E-Seller4u in the future if the consignor commits such an act. In the instance that the consignor is the high bidder (wins the auction) they will also be held responsible for the winning bid amount and all fee's and commission of E-Seller4u

- b. If the consignor should choose to end the auction early there will be a \$25.00 penalty fee per auction lot. This fee will also be assess to any auction that is withdrawn prior to auction but that has started the listing process (picture taking, cleaning, etc)
